Canadian confidence in Canada's ability to protect its economic interests in NAFTA renegotiations up from 2017

National survey released February, 2018 Project 2018-1154A

Summary

A slight majority of Canadians agree or somewhat that Canada holds a lot of leverage or bargaining power that will protect Canadian interests and say that Canada will have a better outcome from the NAFTA negotiations if it forms a united front with Mexico. Over half of Canadians are confident or somewhat confident that if NAFTA were to be renegotiated, Canada could protect its economic interests.

- Majority of Canadians are confident or somewhat confident that Canada can protect its economic interests if NAFTA is renegotiated Just under six in ten Canadians are confident (15%) or somewhat confident (42%) that Canada can protect its economic interests if the North America Free Trade Agreement is renegotiated, while nearly four in ten Canadians are not confident (17%) or somewhat not confident (22%). Four per cent are unsure. The frequency of Canadians who are confident or somewhat confident is up slightly from 2017 (confident: 13%, somewhat confident: 33%).
- Half of Canadians agree or somewhat agree that Canada has a lot of leverage in negotiations to protect its interests When asked about their level of agreement that Canada has a lot of leverage or bargaining power in the negotiations to protect Canadian interests, 13 per cent of Canadians say they agree and 38 per cent say that they somewhat agree, while just over two in five Canadians say they disagree (13%) or somewhat disagree (30%). Six per cent are unsure.
- One in two Canadians say that Canada will be able to negotiate a better outcome from the NAFTA if it forms a united front with Mexico When asked which option will help Canada negotiate a better outcome from the NAFTA negotiations, 51 per cent of Canadians say it is better if Canada forms a united front with Mexico to support and defend each other's interests, while 37 per cent of say that it is better for Canada to solely pursue its own interests. Twelve per cent are unsure.

These observations are based on a Nanos RDD dual frame (land- and cell-lines) hybrid telephone and online random survey of 1,000 Canadians, 18 years of age or older, conducted between January 28th and February 1st, 2018 as part of an omnibus survey. Participants were randomly recruited by telephone using live agents and administered a survey online. The margin of error for a random survey of 1,000 Canadians is ±3.1 percentage points, 19 times out of 20.













Methodology



Methodology

Nanos conducted an RDD dual frame (land- and cell-lines) hybrid telephone and online random survey of 1,000 Canadians, 18 years of age or older, between January 28th to February 1st, 2018 as part of an omnibus survey. Participants were randomly recruited by telephone using live agents and administered a survey online. The sample included both land- and cell-lines across Canada. The results were statistically checked and weighted by age and gender using the latest Census information and the sample is geographically stratified to be representative of Canada.

Individuals randomly called using random digit dialling with a maximum of five call backs.

The margin of error for a random survey of 1,000 Canadians is ±3.1 percentage points, 19 times out of 20.

This study was commissioned by the Globe and Mail and the research was conducted by Nanos Research.
